Name of proposed course of treatment: R-Maxi CHOP and R-High Dose cytarabine (Nordic protocol)

Treatment Summary: Cycle 1: Maxi CHOP: Cyclophosphamide IV bolus, Doxorubicin IV bolus and Vincristine IV infusion on D1, oral prednisolone on days 1-5
 Cycle 2: Rituximab IV infusion on D1+cytarabine IV infusion twice a day on D1+D2
 Cycle 3: Rituximab IV infusion on D1 + Maxi CHOP on D1
 Cycle 4: Rituximab + High dose cytarabine: same as cycle 2
 Cycle 5: Rituximab + Maxi CHOP: same as cycle 3
 Cycle 6: Rituximab + High dose cytarabine: same as cycle 2 + rituximab on D9

Repeated every 3 weeks for 6 cycles in total

I have discussed what the treatment is likely to involve (including inpatient / outpatient treatment, timing of the treatment, follow-up appointments) and location.

The intended benefits

- Curative – to give you the best possible chance of being cured
- Disease control - the aim is not to cure but to control the disease. The aim is to improve both quality of life and survival

Significant, unavoidable or frequently occurring risks:

Common side-effects for all cycles: low white blood cells (neutropenia) with risk of infection, low red blood cells (anaemia), low platelets with risk of bleeding, feeling sick (nausea) and being sick (vomiting), hair loss, sore mouth and ulcers, taste changes, tiredness and feeling weak.

Specifically for maxi CHOP: numbness or tingling in hands or feet, constipation, discoloured urine, irritation of the bladder lining,

Side effects related to prednisolone: irritation of the stomach lining, increased appetite, changes in blood sugar levels, fluid retention, changes in behaviour (mood swings, difficulty sleeping, anxiety or irritability)

Infusion reactions related to rituximab: flu-like symptoms (high temperature, chills, muscle aches, tiredness, dizziness and headache), low blood pressure, flushing and allergic reactions.

Specifically for cytarabine: gritty and sore eyes (conjunctivitis) and you will be given eye drops to prevent this or reduce the severity, rash, diarrhoea

Less common but potentially life-threatening side-effects: severe infection causing organ failure.

Other less common side effects include: changes in the way your heart works - rarely, doxorubicin may cause long-term damage to the heart.

Rarely, cytarabine can affect your nervous system and you must tell your doctor if you feel dizzy or suffer with confusion whilst receiving this treatment. Late effects include a very rare chance of a second cancer

Cancer can increase your risk of developing a blood clot (thrombosis), and having chemotherapy may increase this risk further. A blood clot may cause pain, redness and swelling in a leg, or breathlessness and chest pain - you must tell your doctor straight away if you have any of these symptoms.

Some chemotherapy drugs can damage women's ovaries and men's sperm, with risk of infertility and early menopause in women. I have warned the patient about the likelihood of:

- early menopause in women infertility (in men and in women)

Some chemotherapy drugs may damage the development of a baby in the womb (foetus), leading to the many risks associated with an abnormal pregnancy. Therefore, I have discussed the issues of protected sex. This is an issue for both men and women. The patient has been advised not to become pregnant / not to get a partner pregnant during the period of treatment, and for 12 months (women) / 6 months (men) after treatment has completed
